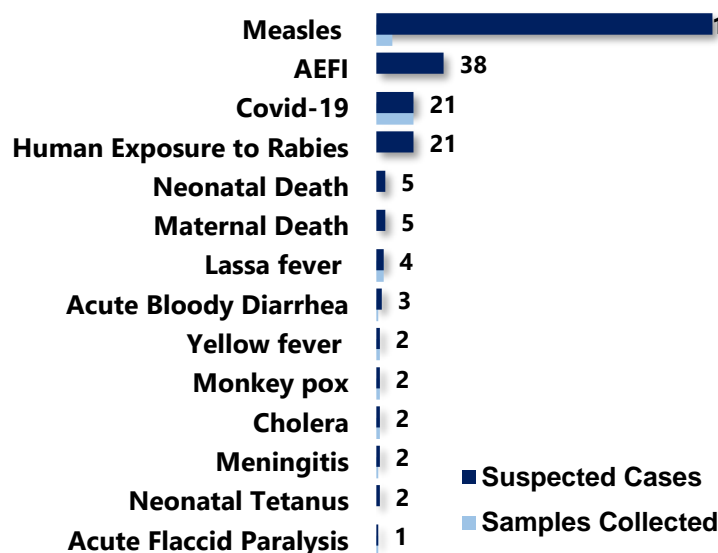

Keynotes and Events of Public Health Significance

- ♦ A total of 298 events of public health importance including 13 deaths were reported
- ♦ Completeness and timeliness of health facility reports were 100% and 98%
- ♦ Ongoing Lassa fever outbreak in two counties
- ♦ Ongoing Measles outbreak in fifteen counties
- ♦ Twenty-one (21) new confirmed COVID-19 cases reported from three Counties

Vaccine Preventable Diseases

Measles

One hundred ninety (190) suspected cases including 1 death reported from Montserrado: Montserrado (139 including 1 death), Margibi (15), Grand Bassa (10), Maryland (7), Nimba (5), Grand Gedeh (4), Grand Cape Mount (2), Bomi (2), River Gee (2), Grand Kru (1), Bong (1), Lofa (1), and Sinoe (1) Counties.

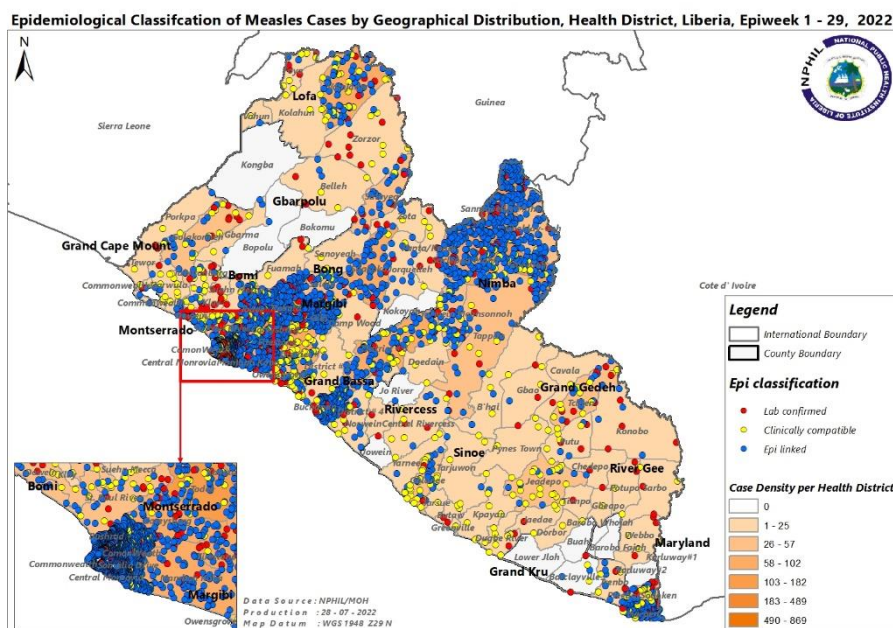
Nine (9) specimens collected and pending testing

Vaccination status among suspected cases

- Vaccinated: (79) 42%
- Not vaccinated: (91) 47.9%
- Unknown: (22) 11.6%

Age distribution among suspected cases

- < 5 years: (127) 67%
- ≥ 5 years: (65) 34%



Cumulatively six thousand ninety-two (6,092) suspected cases have been reported including 70 deaths

- (5,654) 93% confirmed:
 - ✓ Laboratory confirmed: (394) 7%
 - ✓ Clinically compatible: (536) 9.5%
 - ✓ Epidemiologically linked: (4,724) 83.6%
- Non-measles discarded: 447
 - ✓ 26 tested positive for Rubella
- Proportion of samples collected: (972/6,092) 15%
- Proportion of samples tested: (841/972) 87%
- CFR: (70/5,654) 1.2%

Outbreak

Measles: (Situation update as of the 13th December 2021-24th July, 2022)

Montserrado County: Commonwealth, Bushrod, Somalia Drive, St. Paul, Central Monrovia, Todee and Careysburg Districts

One hundred thirty-nine (139) new cases reported from Commonwealth (52), Bushrod (42), Somalia Drive (26), Todee (7), St. Paul (5), Central Monrovia (5), and Careysburg (2) Districts

A total of 3,329 cases have been confirmed

- Median age 6 (1month-59years)
- Vaccinated - (1,592/3,329) 48%
- Unknown - (40/3,329) 1.2%
- CFR (60/3,329) 1.8%

Bong County: Suakoko, Zota, Jorquellah, Salala, and Panta Districts (Situation update as of 20th December 2021-24th July, 2022)

- 👉 No new case reported
- 👉 A total of 205 cases have been confirmed including two (2) deaths
 - Median age 8 (1 month - 38 years)
 - Vaccinated - (36/205) 18%
 - Unknown - (81/205) 40%
 - CFR (2/205) 1%

Lofa County: Voinjama, Foyah, Zorzor and Salala Districts (Situation update as of 21st January – 24th July, 2022)

- 👉 One (1) new case reported from Salayea District
- 👉 A total of 148 cases have been confirmed
 - Median age: 10 (2 months-46years)
 - Vaccinated: (141/148) 95%
 - Unknown: (3/148) 2%

Nimba County: Gbehlay-Geh, Sacleapea-Mah, Zoe-Geh, Tappita, Yarwin Mehnsonnoh, and Sanniquellie-Mah Districts (Situation update as of 20th January-24th July, 2022)

- 👉 Five (5) new cases reported from Gbehlay-Geh (2), Yarwin Mehnsonnoh (2), and Sanniquellie-Mah (1) Districts
- 👉 A total of 564 cases have been confirmed
 - Median age 7 (2 months- 48years)
 - Vaccinated : (117/564) 21%
 - Unknown: (103/564) 18%

Maryland County: Harper and Pleebo Districts (Situation update as of 1st February- 24th July, 2022)

- 👉 Seven (7) new cases reported from Pleebo (4), and Harper (3) Districts
- 👉 A total of 146 cases have been confirmed
 - Median age 7 (7 months-48 years)
 - Vaccinated: (15/146) 10%
 - Unknown: (92/146) 63%

Grand Bassa County: District #1, District#2, District #3A&B, District #4, Owensgrove, and Buchanan Districts (Situation update as of 22nd April-24th July, 2022)

- 👉 Ten (10) new cases reported from Buchanan (8), District #4 (1), and Owensgrove (1) districts
- 👉 A total of 412 cases including one death have been confirmed
 - Median age 7 (1 month-45 years)
 - Vaccinated: (170/412) 41.3%
 - Unknown: (84/412) 20.4%
 - CFR (1/412) 0.2%

Bomi County: Senjeh, Suehn Mecca, Dowein and Klay Districts (Situation update as of 7th March-24th July, 2022)

- 👉 Two (2) new cases recorded from Klay District
- 👉 A total of 58 cases have been confirmed including 4 deaths
 - Median age 7 (1 month-48 years)
 - Vaccinated: (28/58) 48.3%
 - Unknown: (19/58) 32.8%
 - CFR (4/58) 6.9%

Grand Kru: Trehn District (Situation update as of 14th March – 24th July, 2022)

- 👉 One (1) new case reported Trehn District
- 👉 A total of 18 cases confirmed

Rivercess: Central C District (Situation update as of 16 March – 24th July, 2022)

- 👉 No new case reported
- 👉 A total 22 clinically confirmed cases have been recorded
 - Median age 5 (6 months -36 years)
 - Vaccinated: (5/22) 22.7%
 - Unknown: (14/22) 63.6%
 - CFR: (1/22) 4.5%

Margibi County: Firestone, Gibi, Kakata, and Mamba Kaba Districts (Situation update as of 28 February–24th July, 2022)

- 👉 Fifteen (15) new cases reported from Kakata (10), Mamba Kaba (3), and Firestone (2) districts
- 👉 A total of 482 cases confirmed
 - Median age 6 (4 months - 67 years)
 - Vaccinated: (252/482) 52%
 - Unknown: (91/482) 19%

Grand Cape Mount County: Gola Konneh, and Garwula Districts (Situation update as of 10 March – 24th July, 2022)

- 👉 Two (2) new cases reported from Commonwealth C and Gola Konneh districts
- 👉 A total of 64 cases have been confirmed
 - Median age 12 (2 months – 23 years)
 - Vaccinated: (52/64) 81.3%
 - Unknown (2/64) 3%
 - CFR: (3/64) 4.7%

Grand Gedeh County: Tchien, Konobo, and Gbao Districts (Situation update as of 10th March –24th July, 2022)

- 👉 Four (4) new cases reported from Tchien (2), and B'hai (2) districts
- 👉 A total of 56 cases have been confirmed
 - Median age 6 (6 months-35 years)
 - Vaccinated (22/56) 39%
 - Unknown: (16/56) 29%

Gbarpolu: Belle and Kongba Districts (Situation update as of 22nd February- 24th July, 2022)

- 👉 No new case reported
- 👉 A total of 13 cases have been confirmed
 - Median age 10 (1-24 years)
 - Vaccinated: (5/13) 38.5%
 - Unknown: (2/13) 15.4%

Sinoe: Gblonee, Dugbeh River, and Jedepo Districts (Situation update as of 19th May -24th July, 2022)

- 👉 One (1) new case reported from Kpanyan District
- 👉 A total of 91 cases have been confirmed
 - Median age 6 (2 months -38 years)
 - Vaccinated: (51/91) 56%
 - Unknown (22/91) 24%

River Gee: Chedepo and Putu Districts (Situation update as of 29th June- 24th July, 2022)

- 👉 No new case reported
- 👉 A total of 10 cases have been confirmed
 - Median age 10 (9months-48 years)

Public Health Actions

- 👉 Phase 2 of the nationwide immunization campaign is ongoing:
 - Target 313, 817 children
 - Age group 9-59 months from July 18-24, 2022
 - Supported by WHO and UNICEF
- 👉 Continue case management and follow up with home-based cases (Maryland and Rivercess) Counties
- 👉 Airing of measles prevention and control messages on going (Rivercess, Bong, and Lofa) Counties

Challenges

- Limited essential medications/ medical supplies for case management
- No support for response making it difficult to get information from the field (Bong)
- Limited specimen collection kits for measles (Margibi)

Acute Flaccid Paralysis (AFP)

- 👉 One (1) case reported from Montserrado County
- 👉 Specimen was collected and pending shipment
- 👉 Cumulatively, seventy-four (74) cases have been reported

Neonatal Tetanus

- 👉 Two (2) cases reported from Montserrado and Bong Counties
- 👉 Cumulatively, thirty-three (33) clinically diagnosed cases reported

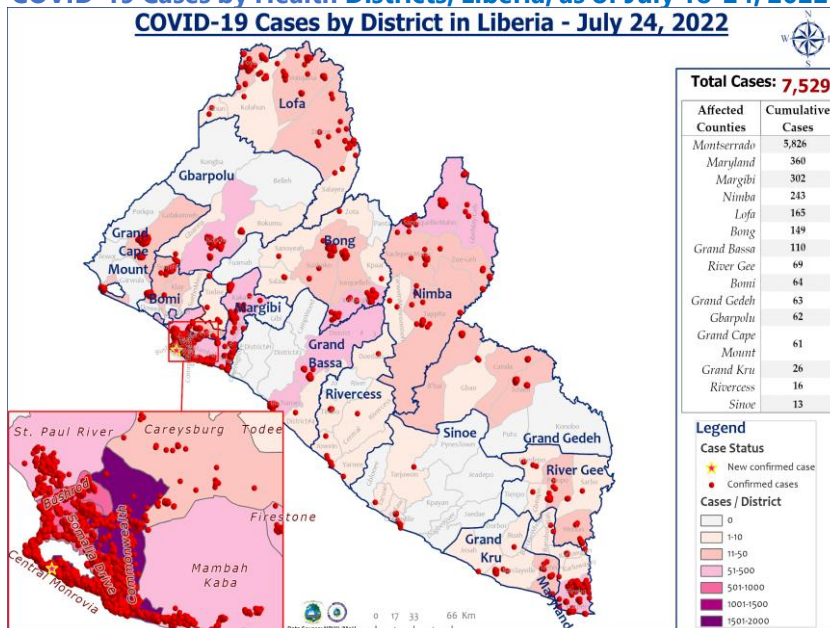
Influenza-Like Illnesses

Coronavirus Disease (COVID-19)

Outbreak

- 👉 Twenty-one (21) new confirmed cases reported from Montserrado (17), Nimba (3), and Grand Bassa (1) Counties
- 👉 Twenty-five (25) active cases were reported from Montserrado (21), Nimba (2) and Grand Bassa (2) Counties
- 👉 A total of six hundred nine (630) confirmed cases have been reported since epi week 1
- 👉 Cumulatively, seven thousand five hundred twenty-nine (7,529) confirmed cases recorded including 294 deaths.
 - 412 healthcare workers (including 8 deaths) reported with 17,657 contacts generated

Public Health Actions

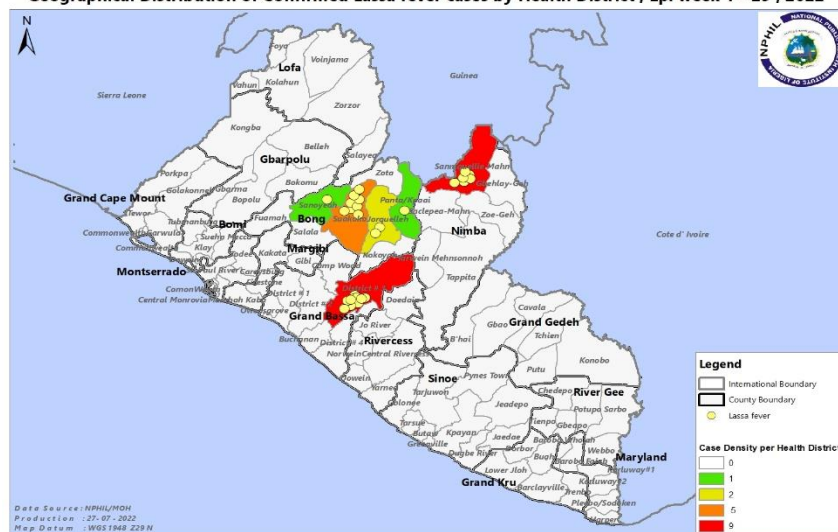
- Weekly IMS coordination meeting
 - On-going.
- Surveillance activities including active case search and case investigation on-going in affected county using WHO interim guidelines
- Case management ongoing for confirmed cases
- Compulsory testing among outgoing travelers as required by country of destination ongoing

Viral Hemorrhagic Diseases

Lassa fever

- Four (4) suspected cases reported from Bong (3), and Montserrado (1) Counties
- Specimens were collected and tested: 1-positive and 3-negative
- Cumulatively, ninety-two (92) suspected cases have been reported including 10 deaths
 - Thirty (30) confirmed cases recorded including 8 deaths
 - CFR: (8/30) 27%
 - Proportion of suspected cases with sample collected (92/92) 100%
 - Proportion of suspected cases with sample tested (90/92) 98%
 - 2 samples rejected

Outbreak

Lassa fever disease: (sitrep update as of June 19, 2022)

- No new confirmed case reported
- All contacts have completed 21 days follow up
- Cumulatively, twenty-nine (29) laboratory-confirmed cases including 8 deaths reported (CFR=28%)

Grand Bassa County: District #3 A&B

- No new confirmed case reported
- Cumulative cases: 11
 - CFR (2/11) 18%
- Cumulative contacts: 42
 - All contacts completed 21 days follow up

Public Health Measures

- Risk communication interventions
 - Ongoing community engagement
 - Encourage radio station (Radio Gorgelee) at LAC to air Lassa fever messages and jingles

Bong County: Suakoko and Jorquelleh Districts

📁 Three new confirmed cases reported

📁 Cumulatively, twelve (15) confirmed cases including (2) deaths (CFR 17%)

- Suakoko District: 8 cases and 2 deaths
- Jorquelleh District: 3 cases
- Sanoyea District: 1 case
- Kpaai District: 1 case

📁 Total of one hundred sixty (160) contacts generated

- All contacts completed 21 days follow up

Public Health Measures

📁 Risk communication interventions

- Daily health talk in all health facilities on priority diseases
- Airing of LF preventive and control messages

📁 Case management

- Isolated, managed, and discharged cases

📁 Surveillance

- Active case search ongoing in the affected health districts
- Heighten surveillance in all districts
- Daily situational reports are shared regularly to national level

Yellow fever

📁 Two (2) suspected cases reported from Grand Kru and Grand Gedeh Counties

📁 Specimens were collected and pending testing

📁 Cumulatively, fifty-five (55) suspected cases have been reported

- Proportion of suspected cases with sample collected (49/55) 89%
- Proportion of suspected cases with sample tested (45/55) 82%
- Samples pending testing (4/49) 8.2%

Diarrheal Diseases

Acute Bloody Diarrhea (Suspected Shigellosis)

📁 Three (3) suspected cases reported from Grand Gedeh, Sinoe, and Montserrado Counties

📁 One (1) specimen collected and pending testing

📁 Cumulatively, two hundred fifty-four (254) suspected cases reported

- One hundred thirty-nine (139) specimens collected; 115 received by the lab
 - 95 tested negative

- 1 positive (Grand Gedeh)
- 11 rejected
- 8 specimens not tested (discarded)

Severe Acute Watery Diarrhea (Suspected Cholera)

- 👉 Two (2) suspected cases reported from River Gee and Sinoe Counties
- 👉 Specimens were collected and pending testing
- 👉 Cumulatively, two hundred eighteen (218) suspected cases reported
 - 117 specimens collected; 67 received by the lab
 - 53 tested negative
 - 5 rejected
 - 9 specimens not tested

Other Reportable Diseases

Animal bite (Human Exposure to Rabies)

- 👉 Twenty-one (21) animal bite cases were reported: Montserrado (6), Maryland (4), Nimba (3), Grand Bassa (3), Margibi (2), Gbarpolu (1), Lofa (1), and Sinoe (1) Counties
 - Persons received Post Exposure Prophylaxis (PEP) (6/21) 29%
- 👉 Cumulatively, one thousand two hundred twenty (1,220) animal bite cases reported
 - Dog bites account for 100%
 - 1-4 doses (PEP) administered to about (203/1,220) 17% of patients

Public Health Actions

- 👉 Administration of post exposure prophylaxis
- 👉 Dogs and cats' mini vaccination campaign ongoing in Montserrado County, to be extended to five counties: Bong, Gbarpolu, Nimba, Lofa, and Grand Cape Mount
- 👉 Community mobilization and awareness ongoing with the use of mobile teams

Meningitis

- 👉 Two (2) suspected cases reported Grand Kru and Grand Gedeh Counties
- 👉 One specimen collected and pending testing
- 👉 Cumulatively, twenty-four (24) suspected cases reported
 - One (1) confirmed

Monkey pox

- 👉 Two (2) suspected cases reported from River Gee and Maryland Counties
- 👉 Specimens were collected: 1 tested and 1 pending
- 👉 Cumulatively, seventeen (17) suspected cases reported, one (1) confirmed

Events of Public Health Importance

Maternal Mortality

- 👉 Five (5) deaths reported: Bong (2), Grand Gedeh (1), Lofa (1), and Nimba (1) Counties

- Cause of death: Sepsis (3), and Post-Partum Hemorrhage (2)
- All deaths occurred at the health facility

📁 Cumulatively, one hundred eighty (180) deaths reported

- Proportion of deaths reviewed (49/180) 27%
- Proportion of community deaths (17/180) 9%
 - Proportion of community deaths reviewed: (8/17) 47%

Neonatal Mortality

📁 Five (5) deaths reported: Montserrado (3), and Sinoe (2) counties

- Causes of death: Birth asphyxia (3), and Sepsis (2)
- All deaths occurred at the health facility

📁 Cumulatively, four hundred eighty-seven (487) deaths have been reported

- Proportion of deaths reviewed (60/487) 12%
- Proportion of community deaths (18/487) 4%
 - Proportion of deaths reviewed from community (8/18) 44%

Adverse Events Following Immunization (AEFI)/Adverse Drug Reaction (ADR)

📁 Thirty-eight (38) cases reported: Grand Bassa (23), Grand Gedeh (12), Rivercess (2), and Maryland (1) Counties

- Related vaccines:
 - Measles – 30
 - Typhoid Conjugate vaccine - 7
 - COVID-19 - 1

📁 Cumulatively: three hundred four (304) events reported with (219/304) 72% related to COVID-19

📁 Proportion of COVID-19 vaccine

- J&J vaccine – (164/219) 75%
- AstraZeneca – (6/219) 3%
- Pfizer – (49/219) 22%

📁 Proportion of other vaccine related events – (85/304) 28%

Public Health Actions

📁 All events were investigated, categorized as *non-serious AEFI and symptomatically treated*

📁 Active case search and community engagement ongoing

Unexplained death

📁 Zero case reported

- 👉 **Timeliness** refers to the proportion of expected weekly IDSR reports received by the next level on time (target: $\geq 80\%$). Time requirement for weekly IDSR reports:
 - Health facility - required on or before 5:00pm every Saturday to the district level
 - Health district - required on or before 5:00pm every Sunday to the county level
 - County - required on or before 5:00pm every Monday to the national level
- 👉 **Non-polio AFP rate** is the proportion of non-polio AFP cases per 100,000 among the estimated population under 15 years of age in 2017 (annual target: $\geq 2/100,000$)
- 👉 **Non-measles febrile rash illness rate** refers to the proportion of Negative measles cases per 100,000 population
- 👉 **Annualized maternal mortality rate** refers to the maternal mortality rate of a given period less than one year and it is the number of maternal deaths per 100,000 live births
- 👉 **Annualized neonatal mortality rate** refers to the neonatal mortality ratio of a given period less than one year and it is the number of neonatal deaths per 1,000 live births
- 👉 **Epi-linked** refers to any suspected case that has not had a specimen taken for serologic confirmation but is linked to a laboratory confirmed case
- 👉 **Confirmed case** refers to a case whose specimen has been tested positive or reactive upon laboratory testing, or has been classified as confirmed by either epidemiologic linkage with a confirmed case, or clinical compatibility with the disease or condition
